OFFERS CONGREGATIONS THROUGHOUT THE ENTIRE STATE OF NEW YORK FINANCIAL AND TECHNICAL ASSISTANCE TO MAINTAIN, REPAIR, AND RESTORE THEIR HISTORIC BUILDINGS. THE PROGRAM WAS LAUNCHED IN 1986 AND IS THE ONLY STATEWIDE PROGRAM IN THE NATION RESPONDING TO THE PRESERVATION NEEDS OF HISTORIC RELIGIOUS PROPERTIES. SINCE ITS INCEPTION, SACRED SITES HAS AWARDED 1,519 GRANTS TO ALMOST 815 CONGREGATIONS THROUGHOUT NEW YORK, REGARDLESS OF DENOMINATION. FOR 2019 THE SACRED SITES PROGRAM PLEDGED 47 GRANTS TOTALING \$573,500 THROUGHOUT NEW YORK STATE, LEVERAGING OVER \$8.6 MILLION IN REPAIRS AND RESTORATION PROJECTS.
