

Dear Deputy Commissioner Mackay:

I write to express my strong opposition to the proposed installation of 5G towers on the Upper West Side, including, but not limited to recently proposed sites: 1900 Broadway, 1886 Broadway and 1880 Broadway as well as sites recently approved by SHPO: 715 Columbus Avenue and 741 Columbus Avenue.

As a Council Member representing this community, I am deeply concerned about the potential negative impacts that these structures may have on our historic neighborhood. I previously expressed my concern in a letter dated January 23, 2023 to the Office of Technology and Innovation (Enclosed).

Historic districts such as the Upper West Side are characterized by unique streetscapes that reflect specific periods and styles of architecture. The installation of towering cellular infrastructure within these districts contradicts the fundamental purpose of preserving their historical integrity and beauty. The current sites outlined above are either in or adjacent to an historic eligible or designated historic district or property, and require further review.

It is imperative we address our community's concerns and explore all possible avenues to prevent the permanent installation of these unsightly and inappropriate towers. Our goal should always be to find a balance between the evolving needs of the city and the imperative of preserving the unique character of our neighborhoods. I urge SHPO to take immediate action and end all plans for installation on the Upper West Side.

Additionally, it is my understanding that these towers are intended to address gaps in the city's current 5G network, and while I certainly support expansion of wireless and cellular services to underserved communities, I have not seen any data to support this need in my district.

Please keep me informed of any updates or developments regarding this issue. I look forward to your prompt response.
